

2010 Print Production Guidelines

Mandatory Requirements

Press Quality PDF files are the **only acceptable file format**.

- All images must be **high-resolution** (at least **300 dpi**).
- All photos and graphics must be in **CMYK mode**, no RGB or Spot colors.
- PDF files should be optimized for Acrobat 5.0.
- Only include crop and registration marks** on covers 1-4 and spine ads (crop and registration marks must be **offset 0.125"** from trim). **No crop and registration marks allowed** on any other ad unit.
- Set page size to trim size of final ad and include all ad graphics and images within the final ad dimensions.
- Do not combine several ads on one page, or multiple pages in one PDF file.
- Do not embed any color management profiles in your pdf.
- Embed all fonts** into your pdf. **Do not subset font families.** [click here for help](#)
- SWOP-certified **proof**, including SWOP approved color bars, required for all color ads. Laser proofs acceptable for b&w ads only.
- Keep copy on all bleed ads at least 0.5" from gutter and 0.25" from top, bottom and face.
- Build black type from **100% black**, not CMYK.
- Please do not use special characters in file name.

Native file applications (such as Quark, InDesign, Photoshop, Illustrator) are not accepted. All ads must be submitted in final form. We can not make modifications or corrections to ad files. **Ads that are not acceptable will be returned to the advertiser for correction.**

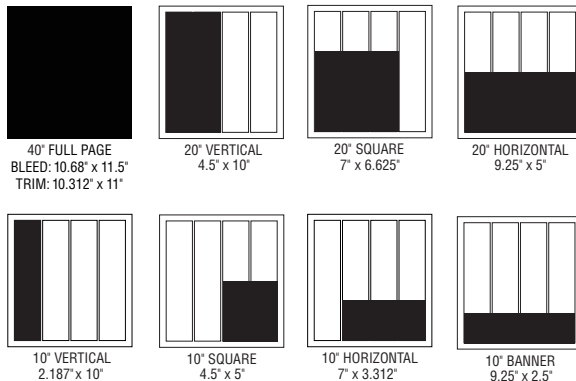

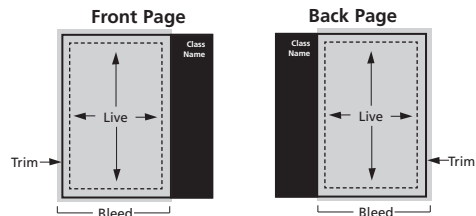
2.18" wide x 3" high (no crop or registration marks)

Bleed on top, bottom, right: 7.125" x 11.5"
Trim: 6.625" x 11"
Live: 5.625" x 10"

Other Covers (2-4)

Bleed on 4 sides: 10.812" x 11.5"
Trim: 10.3125" x 11"
Live: 9.312" x 10"

Spine

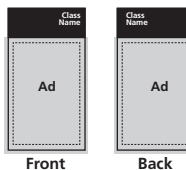

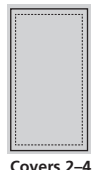
First Cover
